Following are answers to commonly asked questions regarding our revenue share option:

Q: Why should we offer a background check program to our members?

By offering background screening and risk management services to your members, you will assist them in providing safe and secure staff (volunteer and employee) members to those served, at a nationally discounted cost.

Q: How does the referral revenue share arrangement work?

All members of your organization that enroll in this program will generate revenue share dollars for your association. These shares will be paid at a rate of 5% of the gross revenue generated (less state and court fees) for 24 months post enrollment.

Q: When will revenue share payments be made?

Payments will be made on a quarterly basis for the duration of the agreement between your association and MyBackgroundCheck.com

Q: How do our members sign up for your services?

They simply click on the background screening link from your web site and fill out a simple enrollment form. A custom webpage will be developed specifically for your member. They can then add the link to this custom page directly to their website allowing their chapters to begin utilizing the service.

Q: Are there any additional steps we would need to take to get credit for the referral?

No. Once your member links to our enrollment form website you will be given credit for the referral and immediately become eligible for the revenue share dollars.

Q: What if our association wishes to utilize this service for our staff?

Your program and/or parent organization can be one of your referrals. You will still receive the revenue share dollars.

Q: What if our member is already conducting background screening at a lower cost?

We will work directly with your members on a case by case basis to see if we can offer this program to them at a price point within their budget. In many cases our clients find that our program offers many additional risk management features that make any cost differential insignificant.

Q: What is our liability risk?

There are no liability risks to your association. All relationships are between MBC and the members you refer. We provide full compliance support to your members covering local, state and national regulations including the Fair Credit Reporting Act (FCRA).
